# **Social Security Benefits in 2023**



# **ABOUT THIS WEBINAR**

According to the Social Security Administration (SSA) approximately 70 million Americans will see an 8.7% increase in their Social Security benefits and Supplemental Security Income (SSI) payments in 2023. On average, Social Security benefits will increase by more than \$140 per month starting in January. Top 5 Changes to Social Security in 2023: (1) Cost of living adjustment rises; (2) Maximum taxable earnings going up; (3) Maximum Social Security benefit also set to increase; (4) Average benefit for spouses and disabled workers is increasing; and (5) Social Security adjusts earnings test exempt amounts.

Supplemental Security Income (SSI) provides critical financial help to aged, blind, and disabled people who have limited income and resources. Social Security Disability Insurance (SSDI) pays disability benefits to you and certain family members who meet our definition of disability if you worked long enough – and recently enough – under Social Security. In this webinar participants are provided important information about the basics of the SSDI and SSI programs and the application process.
