Background

- TRICARE Basic (i.e., medical) program covers a wide range of medically necessary and appropriate services for the diagnosis of Autism Spectrum Disorder (ASD)
- Autism Care Demonstration (ACD) is authorized under the demonstration authority to provide clinically necessary and appropriate Applied Behavior Analysis (ABA) services for the core symptoms of ASD

Background

- TRICARE (i.e., medical) covers: ACD covers:
 - Occupational therapy
 - Physical therapy
 - Speech and language therapy
 - Case Management
 - Prescription medications
 - Psychological services
 - Psychological testing
 - Etc.

- - ABA
 - √ Tiered model
 - ✓ Sole provider model only
 - Autism Services Navigator (ASN) (where applicable)

Beneficiary Eligibility for the ACD

- Must be a TRICARE eligible beneficiary enrolled in an eligible TRICARE Plan Option.
- Must receive a definitive diagnosis of ASD from an approved ASD-diagnosing provider
- 1st Referral must include
 - Diagnostic and Statistical Manual for Mental Disorders Fifth Edition (DSM-5) checklist
 - Validated assessment tool (VAT) (one time requirement)
- Dependents of Active Duty Service Members (ADSMs) must be
 - Enrolled in the Exceptional Family Member Program (EFMP)
 - Registered in the Extended Care Health Option (ECHO)

*The contractor shall assign a non-clinical outreach coordinator for up to 180 calendar days to beneficiaries who require assistance in meeting the eligibility requirements

Outcome Measures

- Initial outcome measures must be completed prior to beginning ABA treatment services
 - Outcome measures can be completed by the diagnosing provider or by a provider who receives authorization
- All outcome measures must be completed prior to issuing subsequent ABA treatment authorizations

Autism Services Coordination

- Once all ACD eligibility requirements are met, an Autism Services Navigator (ASN) is assigned to new beneficiaries entering the program.
- ASN applicable to beneficiaries enrolled to Health Net Federal Services (HNFS) and Humana Military (HM).
- TRICARE Overseas Program, U.S. Family Health Plans, and TRICARE For Life are not required to provide the ASN; however, existing case management services must provide support when requested by the beneficiary.

Autism Services Coordination

- The ASN is a contractor-employed ASD specific care manager who:
 - Serves as the primary point of contact for the beneficiary/family.
 - Serves as the primary clinical advocate in the health care setting for the beneficiary/family.
 - Oversees the assessment, planning, facilitation, care coordination, and evaluation.
 - Collaborates with all stakeholders for the beneficiary.
 - Develop a Comprehensive Care Plan (CCP).
 - Facilitate continuity of care and transferring documents when a beneficiary moves, sponsor retires, or a treating provider becomes unavailable.

Autism Services Coordination

- A CCP is a plan that is developed and maintained by the ASN
- The CCP must be completed within 90 days and will:
 - Identify all care and services for each new beneficiary in the ACD.
 - Document outcome measures and timelines.
 - Document PCS timelines (where applicable).
 - Develop a discharge/transition plan.
- CCP is updated every 6 months in line with the continued authorization of ABA services

Note: CCP is not the same as the ABA Treatment Plan



Improving Health and Building Readiness. Anytime, Anywhere — Always



Initial ABA Authorization

- Once a verified referral is complete, an initial assessment authorization is issued to an ABA provider.
- Once the assessment and treatment plan is complete, and following clinical necessity approval, an ABA treatment authorization (valid for 6 months) is issued.
- For subsequent ABA treatment authorizations, ABA providers must submit updated treatment plans timely.

Next 2-year ABA Referral

- If additional ABA services are recommended beyond the initial 2-year period, the beneficiary must obtain a new referral from an approved diagnosing/referring provider.
- An updated DSM-5 Checklist is required.
- The requirements for a new referral can be completed up to 6 months in advance of the expiring referral.







Access to Care (ATC)

- ATC standards
 - 28 days to obtain an ABA assessment
 - 28 days to begin ABA treatment
- Active provider placement
- MTF directed referrals/family choice does not ensure ATC, i.e.,
 - Specific provider
 - Specific time of day
 - Specific location

Parent/Family

- Requirement for parent participation
- HNFS and HM also provide the following information on their websites:
 - "New to the ACD information toolkit"
 - Local area supports/resources
 - Military installation supports/resources
 - Information about clinical/non-clinical services
 - Mental health services, including telehealth resources
 - Military OneSource, Morale/Welfare/Recreation services, etc.
 - Parent-mediated services

Medical Team Conferences

- Medical team conferences are for the purpose of the treating providers to periodically meet to discuss the beneficiary and the overall program and progress towards goals.
- Who should attend?
- Criteria for reimbursement set by American Medical Association guidance
